

Hello my name is André Joseph. I am committed to inspiring the world through my stories on film:

- Build Awareness
- Social Responsibility
- Take Action Against Injustice

I understand what it is like to be victimized for being different from others in high school. I recognized over time that over time, my voice in the visual medium can inform and enlighten audiences. Though my short film DISMISSAL TIME, I intend to help young people not feel alone and for adults in authority to bring light to darkness.

ACT 1 The Setup





- Prep school student T.K. Clark gets pranked by students due to interest in his classmate Candice Romano.
- The only teacher with sympathy for T.K. is his history teacher Sharon Vance who sees his potential.
- T.K. gets pulled out of class to be questioned by guidance counselor Mr. Deacon about a "kill list" he has allegedly wrote. Professing innocence, T.K. is unaware that the meeting is being filmed.
- At home, T.K. sees on the school's social media page that the "kill list" was a prank that leads to him being cyberbullied. He contemplates suicide.

ACT 2 The Cover-Up





- Days after T.K.'s attempted suicide, Ms. Vance gets called into Principal Thompson's office where she's questioned about his suspicious behavior. While Ms. Vance speaks highly of T.K., Thompson promises a quick investigation and a school wide announcement if he's found innocent.
- During class, Vice Principal Simonson gets on the loudspeaker. Rather than address T.K., the homecoming dance is announced which outrages Ms. Vance.
- Ms. Vance takes action on her own by questioning two students with grudges against T.K. She soon realizes that her student Chantelle Gilbert was responsible due to T.K.'s interest in her friend Candice.

ACT 3 Exposing the Truth





- Ms. Vance brings her suspicions to Thompson and the school administration.
 She learns that T.K. is leaving school as a result of what transpired and the administration wants to move on.
- Ms. Vance expresses disgust at the school treating T.K. like an expendable student. In retaliation, Thompson threatens her job because of her actions against the suspected students involved in the prank. Ms. Vance decides to quit in protest.
- Ms. Vance meets with T.K.'s family to explain what really happened. They take their story to the local press which results in charges against Chantelle and humiliation for the school. Meanwhile, T.K. is expected to recover.

LEARNING MOMENTS The Themes of Dismissal Time



- When acts of cruelty against students happen, teachers must encourage students to be socially accountable. Speak up and call out the wrongdoing.
 Often times, students never know what's going on with a victim internally.
- Students of color should never be judged based on their race, personal habits, interests, or social status. Educators especially cannot judge a student at face value.
- Schools need to do a better job addressing the mental health of students. In addition to hiring specialized counselors, create specialized classes once a week where students can express themselves freely outside of academic responsibilities.

WORKSHOP PREMISE

Reenactment Exercise

- EXERCISE PREMISE Two scenarios of the same scene: Have teachers and students reenact the ending scene. Make the students play the administration and one teacher.
 - Scenario 1: Administrator runs down the stats about the troubled student and makes assumptions. Teacher who only
 sees the troubled student as a name on a roll sheet makes a half-hearted defense for him/her.
 - Scenario 2: Administrator runs down the stats about the troubled student and makes assumptions. Teacher who
 knows the student and his/her potential well enough makes a powerful case to defend him/her.
 - For the Audience: Think about how you would support the student; how do you engage with an administrator
 responsibly when addressing a student's problem; and what can a school do to ensure a student can be treated fairly
 and equally?
 - Learning Outcome: Teachers must learn to be more empathetic towards their students to earn their trust not only in academics but also confiding in their personal issues both in and outside the classroom.
